Although Winco Contractors makes every effort to accommodate individual preferences, business needs may make the following conditions necessary: overtime, shift work, a rotating work schedule that includes Saturday and/or Sunday. I understand and accept these as conditions of my employment. I understand that Winco Contractors will not employ persons who use illegal drugs, and/or abuse alcohol or legal drugs, and that Winco Contractors retains and exercises the right to screen from employment such individuals. Further, I agree to abide by Winco Contractors Substance Abuse Policy as stated in the handbook a copy of which will be provided if I am employed by Winco Contractors. TRUCK DRIVERS / POWER EQUIPMENT OPERATOR / LABORER RESPONSIBILITIES

The following description of essential job functions does **not** specify each and every duty an operator / laborer may be called upon to perform. Operators / laborers may be assigned such duties that, in the opinion of his / her supervisor, are reasonably related to the driver / operator's primary job responsibilities, as may be needed to provide proper customer service, or as may be required to assist other employees and compliment Winco Contractors efforts generally.

- Access equipment. Must climb steps up to six (6) steps per one (1) hour.
- Operate equipment. Must tolerate sitting up to eight (8) hours when operating equipment.
- Must have sufficient near/far vision to estimate distances and discriminate colors when driving.
- Must use upper extremity to drive equipment, requiring ten (10) lbs. of upper extremity force one hundred (100) times per hour to operate features: bilateral necessary.
- Acquire raw materials. Requires vertically translating parts and equipment weighing ninety (90) lbs. from one (1) to thirty-six (36) inches up to one (1) time per hour. Requires horizontally translating same a distance of five (5) ft., without mechanical assistance.
- Access and acquire tools and equipment. Requires vertically translating same weighing up to sixty (60) lbs. from one (1) to thirty-eight (38) inches up to five (5) times per hour. Requires horizontally translating same a distance of fifty (50) ft., without mechanical assistance.
- Use of various power/hand tools. Requires vertically translating air tool weighing ninety (90) lbs. from thirty-six (36) to forty-two (42) inches up to twenty-five (25) times per hour. Also requires horizontal forces up to fifteen (15) lbs. up to one hundred (100) times per hour. Also, requires grip forces of fifty (50) lbs. up to ten (10) times per hour.
- Access excavations, trenches, bridges and other worksite areas. Requires ladder type climbing up to fifty (50) steps in one (1) hour. Requires walking up to fifty (50) steps in one (1) hour. Requires walking up to two (2) miles in eight (8) hours. Requires tolerance to heights up to sixty (60) feet.
- Access work areas in excavations and trenches with existing construction. Must access spaces with entries twenty-four inches by twenty-four inches (24"X24") and work in spaces with thirty-six (36") inch headroom.
- Perform work and observe safety symbols. Requires sufficient near and far vision and ability to distinguish colors related to safety. Employee must stand during entire shift.
- Ambulate up to thirty (30) ft. on suspended construction six (6) inches in width. Repetitive posture of seventy five (75) times per hour while finishing cement structures.
- Work outside requiring tolerance of outside temperatures including excess heat, cold and precipitation.
